# **QUESTION #1**

Should we be registering players/staff into OSCAR?

#### **ANSWER #1**

After much discussion with Ontario Soccer concerning SAAS fees not being charged if the Outdoor 2020 season is cancelled; SportsEngine has agreed in good faith, given these challenging times, not to collect the SAAS fees applicable to 2020 outdoor season (OSCAR) registrations if the season in **cancelled in its entirety.** 

As a result, Ontario Soccer will not collect both Outdoor Player Registration fees and OSCAR, powered by SportsEngine, SaaS fees if the 2020 Outdoor Season is **cancelled in its entirety.** 

As per OS BULLETIN I2020-037

If the season does start and players choose to withdraw or your Club decides not to offer programs before the season begins, please "**REMOVE**" those players from OSCAR to ensure those registration aren't charged. This is a current feature in OSCAR, that may be removed/corrected in the future.

Just making them Inactive would mean they participated and would still be charged.

# \*\*\* IMPORTANT UPDATE from May 26\*\*\*

If players are doing ONLINE VIRTUAL TRAINING they need to be registered in OSCAR and provide the district with a list of these teams. If the Outdoor season is cancelled in its entirety, the players registered in OSCAR will not be charged a player registration fee or a SAAS fee.

IF your club has teams registered in OSCAR currently and are not doing ONLINE VIRTUAL TRAINING, it is HIGHLY recommended that you "REMOVE" the players from OSCAR due to the fact that if/when OS declares that there is a start date for OUTDOOR 2020, no matter what that season may look like, your club will be charged the player registration fee and the SAAS Fees.

EMSA suggests that you "REMOVE" these players asap. DO NOT MAKE THE PLAYER INACTIVE

Prior to removing players you may want to ensure that you have your CSV file saved just in case there is an outdoor season and you decide to participate in it. This will then make resubmitting the teams easier for your club.

# **QUESTION #2**

Our club has paid our player registration deposit invoices for Outdoor 2020.

- a) if the season is cancelled will we be fully reimbursed or will it be forwarded to 2021
- b) if the season is shortened i) will player registration fees be pro-rated?
  - ii) will the SAAS fees be pro-rated?

#### **ANSWER #2**

EMSA will provide information on a player registration refunds once more information is known about if/when an Outdoor 2020 season will begin. In the meantime, if your club needs to discuss their financial situation in more detail please feel free to contact emsada@rogers.com.

- b) i) The question has been raised as to pro-rated player registration fees if the season is shortened; currently we are awaiting a response. When more information is provided, we will certainly advise our members. Currently we only know that OS will not charge if the season is cancelled in its entirety
- ii) as the SAAS fees are a user fee, it is currently felt that even if the season is shortened that this fee would not be pro-rated and the full \$3.10 would be charged fully.

## Addition:

In addition EMSA has been advised that

- 1. If Ontario Soccer cancels the entire season all SAAS fees will be returned.
- 2. If Ontario Soccer does not cancel the season, however a club decides to cancel the season <u>SAAS</u> fee is payable if players are entered into the registration system.
- 3. If Ontario Soccer does not cancel the season and a club does cancel the <u>season</u> without registering players into OSCAR no SAAS fee is payable.

Only register players that agree to play if there is a season or a part of a season. If you are concerned that a player may not be participating if there is a season, please 'remove' the unapproved player from OSCAR

Just making them Inactive would mean they participated and would still be charged.

# **QUESTION #3**

What is the deadline for player registration?

## ANSWER #3

The OS Bulletin in regards to deadlines for registering players refers to Youth Provincial Division and Youth Regional Division Player deadlines. EMSA's District players (EMDSL, MMSL, WOSL, LAWSL) do not need to be registered into OSCAR until a future date as to when a start date may be decided on. Clubs that have players playing the district, if they wish can start to register players in OSCAR; however please review Question #1 for further information

Currently EMSA is only going in OSCAR to review/approve staff. Notes will be made in the comment box beside the staff's name, please also submit NCCP# or comments in the comment box.

The approval of players will be done at a later date

Answer #9

Ontario Soccer has extended the deadline for registration of the Ontario Cup until May 6, 2020.

Ontario Soccer also acknowledges the difficult financial times that some organizations may be facing during this COVID-19 crisis. As a result, the Ontario Cup entry fee deadline has been extended beyond the entry deadline.

Payment for the Ontario Cup will be due by no later than May 25, 2020.

# **QUESTION #10 updated May 26th**

Our club wants to keep our players engaged in training, so we have provided them online drills/training that we suggest that they continue to do at home. Will they be covered for insurance if they are injured when they are participating in the drills/training?

ANSWER #10

Please review OS Bulletin IS2020-039 (April 22, 2020)

Many of you have been providing video training opportunities for your players and EMSA supports your efforts to keep your players connected. However, we have confirmed with Ontario Soccer that there would be no insurance coverage available through Ontario Soccer for a player who injures themselves during a remote training session if they are not registered.

Please be advised insurance coverage will only be provided to participants registered and in good standing with Ontario Soccer. Any person providing training must also be registered. This includes but is not limited to coaches, instructors, and assessors. Any person participating in virtual training must be registered. This includes but is not limited to players and match officials. Those individuals not registered with Ontario Soccer will not be eligible for insurance coverage through Ontario Soccer.

Indoor Player Registration expires May 31, 2020.

#### **UPDATE**

## **QUESTION #11**

When do SAAS fees get charged, when the club enters the player/staff names into OSCAR or when the district approves them on OSCAR?

Answer #11

The SAAS fee is a registration user fee, the SAAS fees will be charged to the club when the player/staff are registered into OSCAR.

# **QUESTION #12 updated May 26**

Our coaches were signed up for the courses that were being offered, but has since been cancelled due to COVID 19. When and how will they be able to take the courses.

#### Answer #12

Active Start, Learn to Train, Fundamentals and Soccer for Life are all available online. The on field session will be completed at a later date, hopefully in September or October, which will then conclude the workshop.

## QUESTION #13 added May 26

I saw an OS Bulletin that allowed 4 players and a coach to train on field, is this correct?

#### Answer #13

This information was incorrect and has since been clarified via OS Bulletin I2020-054.

Clubs are not allowed to have their teams practice in person. Anyone club promoting in person training may face disciplinary actions.
